Many of you were shocked at how small the refunds were last year, hopefully all withholding has been adjusted to give you the refund you received in the past. One of the biggest changes is the W4 for withholding that all your employers wanted you to fill out. This is a very confusing form. We will find out shortly if you filled it out correctly.

Please remember that if you only file a Michigan, you do not need an appointment. Just drop it off or stop in any time. IF you make an appointment you will be charged the minimum fee of \$99.

I no longer need to know if you have health insurance any more as there is no longer a penalty. I do still need your form 1095-A form if you purchased your insurance for your self or anyone else on your tax return, from the marketplace.

I am required to have proof in my file of all the children you claim on your tax return. I must have something every year. If you have brought be their SS cards and birth certificates, I should still have those. But ~ IRS requires that I have something with their name and your address. There are huge fines if I don't have that in my file. Please understand that this is IRS requiring this so bring me school record, doctor/dentist receipt, college transcript, child care statement or anything else with their name and your address.
